### ***RCTI Agreement***

**Note:** All Suppliers with an ABN must sign an RCTI Agreement before J.K. Recycling will issue payment. This agreement allows JK Recycling to create a Tax Invoice on your behalf. Suppliers without an ABN do not need to sign the RCTI Agreement, but they must sign a Declaration by Supplier or 46.5% of the total purchase value will be withheld by J.K. Recycling.

Between J.K. Recycling and the Supplier.

In consideration of the Supplier agreeing to make supplies to J.K. Recycling and J.K. Recycling agreeing to receive such supplies, the parties agree as follows:

1. J.K. Recycling can issue tax invoices in respect of the supplies.
2. The Supplier will not issue tax invoices in respect of those supplies.
3. The Supplier acknowledges that it is registered for GST when it enters into this agreement and that it will notify J.K. Recycling if it ceases to be registered.
4. J.K. Recycling acknowledges that it is registered for GST and that it will notify the Supplier if it ceases to be registered.
5. J.K. Recycling indemnifies the Supplier for any liability for GST and penalty arising from an understatement by J.K. Recycling on a tax invoice for the GST payable on the specified supplies.
